ARTICLES OF INCORPORATION OF FRIENDS OF THE ART MUSEUM OF THE AMERICAS

To: Recorder of Deeds, D.C. Washington, D.C.

We, the undersigned natural persons of the age of twenty-one years or more, acting as incorporators of a corporation, adopt the following Articles of Incorporation for such corporation pursuant to the District of Columbia Non-Profit Corporation Act:

First: The name of the corporation is Friends of the Art Museum of the Americas.

Second: The period of duration is perpetual.

Third: The purposes of the corporation are educational, cultural and charitable in order to foster, encourage, stimulate and promote interest in art, artists and artistic works of the Americas. To these ends, it may carry-out the following activities:

- a. Undertake fund-raising activities in order to provide financial support for such activities of the Museum as may be mutually agreed between the parties;
- b. Participate in all types of activities related to these purposes and which are in the interests of the Museum and the corporation;
- c. Foment, stimulate and promote interest in Latin American art, artists, artistic works and objects and particularly those of contemporary creation;
- d. Provide funds for the purchase of such artistic works for the permanent collection of the Museum;
- e. Sponsor, organize and/or otherwise support conferences and seminars which foster appreciation of art in the Americas. Finance, as appropriate, the preparation, publication and distribution of books, brochures or audiovisual materials relating to art in the Americas.
- f. Increase and improve the knowledge and appreciation of the products of artists throughout the Americas by sponsoring, organizing and presenting exhibitions in the United States and other countries.

- g. Grant stipends, fellowships or commissions to promote the study of contemporary Latin American art and its creation;
- h. Cooperate with other organizations, both governmental and nongovernmental including the Organization of American States, that have a special interest in the promotion of the arts and culture of the Americas; and
- i. Operate exclusively for the accomplishment of educational, cultural and charitable purposes within the meaning of Section 50l(c)(3) of the United States Internal Revenue Code of 1954, as amended.

It shall be understood that all of the above mentioned objectives, purposes and powers shall be regarded as independent objectives, purposes and powers, together with all the powers conferred on the corporation under the District of Columbia Non-Profit Incorporation Act.

Fourth: The Corporation will have members.

Fifth: The qualifications and rights of members shall be as provided in the by-laws of the corporation.

Sixth: The manner of election or appointment of directors and officers of the corporation shall be as provided in the by-laws of the corporation.

Seventh: The corporation shall have all of the powers necessary and incidental to the carrying out of the above purposes, including, but not limited to, powers granted to it under the District of Columbia Non-Profit Corporation Act, provided, however, that:

- A) The corporation shall not have or exercise any power or authority, either expressly, by interpretation of by operation of law, nor shall it directly or indirectly engage in any activity, that would prevent it from qualifying (and continuing to qualify) as a corporation described in Section 501(c) (3) of the Internal Revenue Code of 1954, contributions to which are deductible for federal federal income tax purposes:
- B) No part of the activities of the corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation; nor shall it in any manner or to any extent participate in, or intervene in (including the publishing or distributing of statements) any political campaign on behalf of any candidate for public office; nor shall it engage in any activities that are unlawful under the laws of the United States of America, the District of Columbia, or any other jurisdiction where such activities are carried on; nor shall it engage in any transaction defined at the time as "prohibited" under Section 503 of the said Code;
- C) The corporation shall never be operated for the primary purpose-of carrying on a trade or business for profit, and no part of its assets or net earnings shall be used, nor shall it ever be organized or operated, for purposes that are not

exclusively charitable or educational within the meaning of Section 501(c) (3) of the said Code;

- D) No compensation or payment shall ever be paid or made to any officer, director, trustee, or organizer of the corporation, or substantial contributor to it, except as a reasonable allowance for actual expenditures or services actually made or rendered to or for the corporation; and no part of the assets or net earnings, current or accumulated, of the corporation shall ever be distributed to or divided among any such persons; provided, further, that no part of such assets or net earnings shall ever be used for, accrue to, or inure to the benefit of any member or private individual within the meaning of Section 50l(c)(3) of the said Code;
- E) In the event of termination, dissolution, or winding-up of the corporation in any manner or for any reason whatsoever, its remaining assets, if any, shall be distributed to (and only to) an organization with similar purposes which has established tax-exempt status under Section 501(c) (3) of the said Code:
- E) Any references herein to any prov1s1on of the Internal Revenue Code of 1954 shall be deemed to mean such provision of the Internal Revenue Code of 1954 as now in effect or as hereafter amended, supplemented, or superseded.
